## CONSENT FOR BACKGROUND CHECKS

As an applicant for volunteer service or employment with Albuquerque Pride, I recognize that beginning volunteer service or employment with Albuquerque Pride is conditional upon my successfully passing reference and background screenings. I understand that Albuquerque Pride may conduct Reference and Background Checks thoroughly and within the confines of all applicable state and federal laws.

During the application process and at any time during the tenure of my volunteer service / employment with Albuquerque Pride, I hereby authorize a background check, on behalf of Albuquerque Pride to procure an investigative consumer report which I understand may include information regarding my character, general reputation, or personal characteristics. This report may be compiled with information from courts' records repositories, departments or motor vehicles, past or present employers and educational institutions, governmental occupational licensing or registration entities, business or personal references, and any other source required to verify information that I have voluntarily supplied. I understand that I may request a complete and accurate disclosure of the nature and scope of the background verification; to the extent that such investigation includes information bearing on my character, general reputation, or personal characteristics.

## READ CAREFULLY BEFORE SIGNING

The event titled Albuquerque Pride will have various events throughout the year. To facilitate and organize the event, Albuquerque Pride, the organizing body of the event, shall require the assistance of volunteers and vendors.

A "Volunteer" is a person who contributes his or her time to the event to assist in various aspects of the event. A Volunteer shall sign below in his or her individual capacity.

A "Vendor" is a person or a company who will assist Albuquerque Pride with the logistical aspects of the event, and such term shall include any employees, officers, directors, agents, and volunteers of the Vendor. In the event a Vendor is a company, the waiver herein shall be signed by the contracting party; and the waiver shall include any and all persons that the Vendor allocates to perform work at the event, including without limitation, the Vendor's employees, officers, directors, agents, and volunteers.

In no way shall these definitions be for limitation purposes, but rather they serve as examples of the persons covered by this Release. A Volunteer will receive no compensation from Albuquerque Pride. A Vendor may receive compensation only if such arrangement was agreed to, prior to the date of the event.

The "Premises" of the event include, without limitations, Expo New Mexico and all locations that the Albuquerque Pride has secured for the purpose of its event.

Release of Liability and Assumption of Risk: The undersigned Volunteer or Vendor for Albuquerque Pride (collectively "Participant") in attending, aiding, participating, performing, or providing a service for the event Albuquerque Pride will so do at the Participant's own risk.

Albuquerque Pride, its agents, directors, assigns, volunteers, employees and/or committee members shall not be liable for any damages arising from personal injuries or property damage sustained by Participant in or about the premises and/or in connection with the Albuquerque Pride events.

Participant assumes full responsibility for any injuries or damages that may occur to Participant in or about the Premises while attending, assisting, or otherwise participating in the event. The Participant shall fully and forever release and discharge Albuquerque Pride and related Board of Directors, owners, employees, and agents from any and all claims, demands, damages, rights of action or causes of action, present or future, whether the same be known, anticipated or unanticipated, resulting from or arising out of any incident to the Participant while in attendance, assistance, or participation in the event.
